SPACE ASSIGNMENT

Space assignments will be based on your choice of exhibit area and when this contract is received by show management. The show management reserves the right of assignment and to curtail exhibits in whole or part that reflect the character of the show.

PAYMENT OF SPACE RENTAL

The first half of the space rent will be due upon receipt with the balance due March 15, 2025. All additional costs as agreed to by both parties are due and payable at the time of service. Should these terms not be met, EO Media Events, LLC, reserves the right to void this contract without notice. If exhibitor fails to make all payments, EO Media Events, LLC shall avail itself of all remedies allowed under law to recover all amounts due.

CANCELLATION POLICY

No refunds will be given on canceled spaces after March 15, 2025. Any cancellations after that date are still responsible for the full amount of the booth rent. Any cancellations after February 1, 2025 will incur a cancellation fee equal to 30% of the total booth rent. If the performance by EO Media Events, LLC or the exhibitor of their respective obligations under this agreement is delayed or prevented in whole or in part by any acts of God or by any other cause not reasonably within the party's control, the party shall be excused, discharged and released of performance to the extent that such performance or obligation is so limited or prevented by such occurrence without liability of any kind, except that all deposits submitted by the exhibitor shall be forfeited as outlined above.

BOOTH SERVICES

Each 10'x10' or 10'x20' display booth is supplied with an 8-foot back drop and 3-foot dividers. Bulk spaces are not draped. 110 volt power is included in the price of the booth. 220 volt power is available for an additional charge.

USE OF SPACE

All demonstrations or promotional activities must be confined to the limits of the purchased space. Noise resulting from purchased space must not interfere with other exhibitors. No exhibitor shall assign, sublet, or share the space allocated and must show only goods manufactured or dealt in by them in the regular course of business. No firm or organization not assigned exhibit space will be permitted to solicit business within the confines of the exhibiting area. No interference with the light or space of other exhibitors will be permitted.

CARE OF BUILDING AND EQUIPMENT

Exhibitors and/or agents must not injure or deface the walls or floors of the building, booths or the equipment of the booths. If such damage appears, the exhibitor is liable to the owner of the property so damaged. All materials used in decorating must be flame proofed. Combustible materials or explosives are not permitted within the confines of the exhibiting area. Helium balloons/exhibits are not permitted. Terms of conditions regulating exhibitor conduct and responsibilities, fire and safety rules, and conditions set forth by the Deschutes County Fair & Expo Center will be included in the Exhibitor Handbook that will be distributed before the show. These terms are incorporated into this agreement by this reference and incorporated as if set fully herein.

LIABILITY

Neither the Central Agricultural Show, EO Media Events, LLC, or the Deschutes County Fair & Expo Center, nor their representatives, nor any member of the above named will be responsible for any injury, loss or damage that may occur to exhibitor or the exhibitor's employees or property from any cause whatsoever. The exhibitor, on signing the contract, expressly releases the aforementioned from any and all claims for such loss, damage or injury. Exhibit halls will be locked during the time that exhibits are not being shown, and security guards will be on duty. Exhibitors will provide a certificate of liability insurance in the amount of \$1 million listing the Central Oregon Agricultural Show, EO Media Events, LLC, and the Deschutes County Fair & Expo Center as an additional insured.

Set up of exhibits will begin on Friday April 6 at noon and must be completed by show time on the following day.

Dismantling will start at the close of the show on Saturday and be finished by 12 noon the following day.
